Summary	The consideration of the West Pokot County Water Resource Management Regulations by the County Assembly is guided by the Constitution of Kenya (2010), the County Governments Act, 2012, and the Statutory Instruments Act, 2013. Article 185(1) of the Constitution vests legislative authority in the County Assembly, empowering it to enact and approve subsidiary legislation. Section 8 of the County Governments Act mandates the Assembly to exercise oversight over the implementation of county legislation, while Section 11 of the Statutory Instruments Act provides for the tabling, scrutiny, and approval of regulations before they take effect. This stage ensures legislative validation and conformity of the regulations with constitutional principles, county priorities, and the parent Water Resource Management Act, thereby enhancing lawful and effective governance of water resources in West Pokot County.
