Summary	<p>The formulation of the West Pokot County Water Resource Management Bill is anchored in the Constitution of Kenya (2010), which under Article 185(1) vests the legislative authority of a county in its County Assembly to make laws necessary for the effective performance of its functions. Part 2 of the Fourth Schedule assigns counties responsibility for water and sanitation services, thereby empowering them to develop localized legal frameworks for sustainable water resource management. The County Governments Act, 2012 provides guidance on the legislative process at the county level, while the Water Act, 2016 outlines the national principles and coordination mechanisms for water governance. These provisions collectively provide the legal basis for drafting the Bill to regulate, protect, and promote equitable access to water resources within West Pokot County.</p>

Article 185(1) of the Constitution empowers the Assembly to make laws necessary for the performance of county functions, including water and sanitation services as provided in Part 2 of the Fourth Schedule. Upon approval, the Bill becomes law and is published in the County Gazette as an Act of the County Assembly. This stage ensures that the legislative process is completed in accordance with constitutional and statutory provisions, formally establishing the legal framework for effective and sustainable water resource management in West Pokot County.</p>
